## LONG STAY VISA APPLICATION

### CHILD OF A FRENCH NATIONAL OF LESS THAN 21 YEARS OLD OR DEPENDANT

- **The file must have two sets of supporting documents** : originals (which will be returned to you) and copies. If you do not have the original document, you must provide a copy and a letter justifying the absence of the requested document
- **Missing document = incomplete file = high risk of refusal**
- **Visas fees**: equivalent of 99€ in £ sterling.

<input type="checkbox"/>	2.	<b>2 long stay application forms duly completed and signed</b>
<input type="checkbox"/>	3.	<b>2 recent passport-size photographs</b> with a white background
<input type="checkbox"/>	4.	<b>ORIGINAL + PHOTOCOPY</b> : valid passport (less than 10 years old with a minimum validity of 3 months remaining after the expiry of the requested French visa) + copies of the pages containing any personal data
<input type="checkbox"/>	5.	<b>ORIGINAL + 1 PHOTOCOPY</b> : <b>Proof of French nationality of the parent</b> : French ID card or either: <input type="checkbox"/> Certificate of French nationality ; <input type="checkbox"/> A copy of the decree of naturalisation or decree of re-integration of French nationality or registered declaration ; <input type="checkbox"/> Birth certificate stating French nationality.
<input type="checkbox"/>	6.	<b>ORIGINAL + 1 PHOTOCOPY</b> : <b>Evidence of the family link between the child and the French national</b> : • <b>birth certificate of the child</b> with, if applicable, acknowledgement of paternity by a French national; • or a <b>judgement of adoption</b> (verified by a French Tribunal if it is a foreign judgement).
<input type="checkbox"/>	7.	<b>ORIGINAL + 1 PHOTOCOPY</b> : <b>Evidence of the rights of the French national on the child</b> (if the child is minor): • <b>Marriage certificate of the parents of the child and</b> , if applicable, any document related to a separation or a divorce ; • Or any document related to parental custody on the child
<input type="checkbox"/>	8.	<b>ORIGINAL + 1 PHOTOCOPY</b> : <b>if the child is more than 21 years old</b> : • <b>supporting documents of personal revenues of the child</b> ; • <b>supporting documents of personal revenues of the French national</b> and of the lodging conditions in France; • <b>proof of alimony paid by the French national</b>
<input type="checkbox"/>	9.	<b>ORIGINAL + 1 PHOTOCOPY</b> : supporting document about the residence of the parent in France or letter of explanation if specific situation
